

Stallion Service Contract

This agreement is made and entered into this _____ day of _____ ,

by and between _____ hereafter referred to as the "Mare Owner", and **Ken and Pat Smith and Sunrise West Quarter Horses, LLC**, hereafter referred to as the "Stallion Owner".

Ken and Pat Smith are the owners of the stallion **Verily Sixes** AQHA Registration number **3805858**. The named stallion will stand at stud during the **2008** season, hereafter referred to as the "Current Season", at **Frank Dillon Horses**, hereafter referred to as the "Stallion Station".

The mare owner is the owner of the mare named _____

The parties desire to contract for the servicing of the mare by the named stallion during the Current Season.

It is agreed as follows:

The stallion breeding fee will be **\$850.00**, which includes a booking fee of **\$250.00**.

The Stallion Station shall collect all fees on behalf of the Stallion Owner.

Upon payment of the booking fee, which is not refundable, the Stallion Owner reserves for the Mare Owner one season's booking for the Current Season to the named stallion for the service of the mare.

The mare shall remain at the Stallion Station for a sufficient time to be pregnancy checked after having being bred. This can be done 18 days from the last day of service.

Board at the rate of \$7.00 for dry mares, \$9.00 for wet mares will be paid by mare owner.

The balance of the breeding fee plus all unpaid board and expenses including veterinary expenses will be paid when the mare is picked up unless other arrangements are made.

The Mare Owner agrees to allow the Stallion Station to have a qualified veterinarian check the mare for normal breeding conditions and to perform such other veterinary services the stallion owners deem necessary for the proper treatment and protection of the mare and/or foal at side. This is to be at the Mare Owner's expense and will be billed and due as necessary.

During the time that the mare is in the custody of the Stallion Station, neither the Stallion Station nor the Stallion Owner shall be liable for any sickness, disease, or injury which may be suffered by the mare and/or foal at side.

None of the above mentioned fees shall be refundable, but the Stallion Owner guarantees a return breeding the following season either for said mare or her substitute, should a live foal (defined as one that stands and nurses without assistance) not result from this mating. Costs to the Mare Owner on the return breeding will be current mare care costs, veterinary expenses, and a **\$250.00** chute fee.

This contract shall not be assigned or transferred by either party hereto without the consent of the other.

Breeders Certificates will be issued only when stallion breeding fees, mare care, veterinary charges, and other related fees are paid in full.

SHIPPED SEMEN: We will ship cooled semen. There will be no collection charges on the first shipment, but for each additional shipment there will be a **\$100.00** collection fee. The Mare Owner will pay shipping charges and a **\$250.00** refundable deposit on the container. The entire stud fee and deposit on the container must be paid before the shipment is sent.
